A. Last Frontier Healthcare District Financial Statement – June 2025 (unaudited)	J. Lin presented the <i>unaudited</i> Last Frontier Healthcare District Financial Statement for <i>June 2025</i> from the narratives and financial statements <b>provided</b> in the Finance Committee meeting packet.	
B. Finance Directors Report	<p><b>Accounting</b></p> <ul style="list-style-type: none"> <li>We started monitoring the new Fiscal Year budget and plan to send out the P&amp;L monthly report to the managers by the middle of every month so they can monitor their spending levels to budget.</li> <li>We are still working on the Audit Items due by 9/2. As of today, we have 27 items left, out of 111.</li> </ul> <p><b>Purchasing</b></p> <ul style="list-style-type: none"> <li>Purchasing does not have any new substantial changes; they have finished stocking the New SNF with supplies.</li> </ul> <p><b>Floater</b></p> <ul style="list-style-type: none"> <li>We are looking for two new extra floaters. We interviewed three applicants so far, and have two more interviews scheduled.</li> </ul>	
C. CEO's Report	New SNF

	<ul style="list-style-type: none"> <li>Negotiations with Swinerton still ongoing. Our legal counsel is now involved after receiving a letter from them today.</li> <li>USDA has completed their review of close out documents for the USDA loan. Current plan is for that to close in October 2025.</li> <li>Heard plumbing has not been able to try to kill the geothermal well to facilitate further testing of the well at the high school. This has been delayed since last month.</li> </ul> <p><b>Old SNF/Wanerview</b></p> <ul style="list-style-type: none"> <li>No word back from CMS on being able to keep old SNF open.</li> </ul> <p><b>Budget Cuts</b></p> <ul style="list-style-type: none"> <li>A spreadsheet was provided showing projected cuts to be made for each supplemental reimbursement program we participate in and how much it is expected to be reduced each year.</li> <li>We will take last year's reimbursement under these programs and apply the cuts to see what the federal budget cut may mean to our facility specifically.</li> <li>The Voluntary Rate Range Program is the biggest program for us out of all the supplemental programs, so the cuts to that program will be felt the most.</li> </ul>
